1. **Col. JOEL WATKINS** was born about 1737 in Henrico County, VA. He died 2 Jan 1820 in Charlotte County, VA.

"III. JOEL WATKINS of Woodfork, Charlotte, was the third son of Thomas of Chickahominy, and probably was younger than one or more of his sisters. He removed from Henrico to Charlotte when a young man, at the persuasion of his brother-in-law, Col. William MORTON, herein often mentioned. He married AGNES MORTON, sister of Colonel Morton. His residence was a few miles north of Charlotte C(ourt) H(ouse), at Woodfork. He died about the year----. Few men appear to have been more beloved than this excellent old man. "I never knew him," said Mr. Leigh, "and I am very sorry for it, for, according to my information, he was the very best man that ever lived in this world." He was remarkable, says another who knew him well, "for plainness, benevolence, and integrity, a pattern of industry, one of the kindest of friends---the friend of the friendless, one who comforted the widow in affliction, the father to the orphan, a friend to the poor, the adviser of youth, without an enemy, and his death mourned by all." *** "He would court the company of youth." *** "I have heard him compared to the father of his country." Another styled him the "great peacemaker." There was one virtue for which he and his brother Francis were noted, and which deserves mention, I refer to their purity of character as exhibited by a cordial disgust at hearing vulgar and unchaste conversation. Their kindness and politeness might sometimes prevent apparent rudeness to the retailers of such remarks but they gave no sign of encouragement to the conversation; and Col. Joel Watkins would start off to light his pipe. Among the papers of the Hon. John RANDOLPH was found a MS written by himself, of which the following is a copy: "On Sunday, the 2nd day of January, departed this life, at an advanced age, beloved, honored and lamented by all who knew him, Col Joel Watkins, of the county of Charlotte and State of Virginia. Without shining abilities or the advantages of an education, by plain, straightforward industry, under the guidance of old-fashioned honesty and practical good sense, he accumulated an ample fortune, in which, it is firmly believed, and there was not one dirty shilling. These fruits of his own labors he distributed with a promptitude and liberality seldom equaled, but never surpassed, in suitable provision to his children at their entrance into life, and on every deserving object of private benevolence or public spirit; reserving to himself the means of a generous but unostentatious hospitality. Nor was he liberal of his money only. His time, his trouble were never withheld on the bench or in his neighborhood, when they could be usefully employed. If, as we are assured, that peacemakers are blessed, who shall feel stronger assurance of bliss, than must have smoothed this old man's passage to an unknown world."

"He was the youngest son of Thomas and Frances. He married Agnes Morton in 1741 and they moved to Charlotte County where their home, called "Woodfork", was a few miles above the Charlotte County Court House. This section later became Prince Edward County. There are many references to Joel in Bradshaw's History of Prince Edward County. He was a Justice for several terms, the Sheriff in 1762-3, and a Col. in the Militia in 1761. McAllister lists him as a Col. in the Revolution. He was a member of the House of Delegates in 1781. Bradshaw gives an account of an attempt at growing hemp by several people, and Joel Watkins manufactured 1344 pounds of hemp in 1762. Joel was one of the original trustees of Hampden-Sydney College.

Col. Joel Watkins inspired some of the loftiest prose that I have encountered. He was called "a pattern of industry", compared to the Father of his country, and called a great peace maker. Dupuy quotes Mr. John Randolph of Roanoke: "On Sunday, the second of January, departed this life Col. Joel Watkins, beloved, honored and lamented by all who knew him. Without shining abilities or the advantages of an education, by plain, straightforward industry, under the guidance of Old Fashion honesty and practical good sense, he accumulated an ample fortune, in which it is believed that

there was not one dirty shilling." The feeling about him seemed to be summed up in one eulogy about him which I read. It simply stated that he was the "best man who ever lived in this world."

John Dupuy, Captain of Infantry, in the same regiment with his two younger brothers, during the revolution; among his descendants is preserved, as an heirloom, a Spontoan, a military weapon worn by officers of the infantry; he lived in the Southwestern portion of Prince Edward Co., Va., near the Welsh Track Meeting House, now Bethlehem Presbyterian Church [near Abilene, VA]; His homestead fell into the hands of his grandson, Joel W. Daniel, who exchanged it for the farm of his half brother, Robert P. Daniel, in Charlotte Co., Va., whose heirs now reside on it; He and his wife are buried near the site of his residence (burned) in the family graveyard, which was reserved in his will (probated Oct 15, 1832), as a burying ground of his descendants; b. DUPUY, JOHN.--Prince Edward, Aug. 13, 1832. Born Jan. 20, 1756. Enlisted June, 1776, as volunteer in State troops under Capt. Chas. Allen, Lt. Joseph Parks, Ensign James Allen. Col. Merriman being field officer and one Overton, Major or Adjutant. Marched from Prince Edward C. H. through Richmond and Williamsburg to Hampton, where the army was stationed three or four months. Discharged at Portsmouth in January, 1777. In May or June of this year, under a draft on the young unmarried men of the State, requiring one year in the regular service, applicant hired a substitute named Estis, paying him \$400. These troops marched north to join the army, and he knew nothing more of Estis. In

1778, during an alarm, and at which time applicant held a commission in his home company, he volunteered as a private under the above Charles Allen, and marched to Petersburg, the tour occupying a month or so. In January or February, 1781, he volunteered in his home County, Prince Edward, under Capt. John Bibb, himself being lieutenant. Bibb soon resigned and Nathaniel Cunningham was commissioned in his place. The company joined Gen. Greene at Irvin's Ferry, Halifax County, and was attached to Col. Cocke's regiment of Gen. Steuben's brigade. Was in the battle of Guilford. The second day afterward, applicant conveyed prisoners to Halifax C. H., Va., and delivered them to Nathaniel Hunt, stationed there to receive them. After this service, he returned home, according to order by Gen. Steuben, the tour lasting two or three months. Shortly after reaching home he was ordered to Halifax County to receive arms brought from Guilford battle field and convey them to Prince Edward C. H. In the same year, probably August, he was ordered to convey some wounded prisoners, sent from Guilford to Prince Edward C. H., and convey them to Gen. Lafayette, then at Ruffin's Ferry, King William County. From this point he took them on to Jamestown and delivered them to a British ship, the whole service occupying about one month. According to recollection his commission as lieutenant was by Patrick Henry. Henry Dawson, a witness to the declaration, served with applicant in 1776. [p.65]

Jane married **Col. Clement CARRINGTON of Charlotte Co., VA**, son of Col. Paul CARRINGTON of Charlotte Co., VA and Margaret READ. Col. was born 26 Oct 1762 in Virginia. He died 28 Nov 1847.

The Carrington family iintermarried not only with the Watkins family, but also the Venable, Woodson, and Read families, as well as many others that would be familiar to us. There are some excellent postings on the Internet about the READ family, as well as the CARRINGTON family.

The family of Col. Clement CARRINGTON: His mother Margaret Read (Clement⁵, Thomas⁴ Reade, George³, Robert², Andrew¹) was born 1738, and died 01 May 1766. She married Judge Paul Carrington 01 Oct 1755 in VA, son of George Carrington and Anne Mayo. He was born 05 Mar 1732/33 in VA, and died 23 Jun 1818 in Charlotte, VA.

Clement Carrington owned the second-most expensive home in Charlotte Co., VA known as "Edgehill." Clement Carrington was a court justice in Charlotte Co., VA, and he served on the Board of Trustees at Hampden-Sydney College (from which he was a graduate).

Notes for Judge Paul Carrington (father of Col. Clement Carrington):

About 1748-1750, he went to that part of Lunenburg which is now Charlotte County, Va., to write in the clerk's office of Col. Clement Read, which was located at his seat, "Bushy Forest," and to study the law under him. He began to practice at twenty-one, and having practiced in his county as an attorney for twelve months, he was recommended by his county court as worthy, etc., and in May, 1755 he received a license to practice, signed by Peyton Randolph, John Randolph, and George Wythe. He met with success in his profession from the first.

He was married October 1, 1755, by Rev. William Kay, to Margaret, second daughter of Col. Clement Read. They resided at "Mulberry Hill," near the junction of the Little Roanoke with Staunton River, on an elevated and beautiful site. He was appointed king's attorney of Bedford County, May 3, 1756; major of Lunenburg militia in 1761; and colonel of Charlotte militia, December 3, 1764. He represented Charlotte in the House of Burgesses from its first formation from Lunenburg in March, 1765, until 1775. His first wife died May 1, 1766, and he left a record that "she was the best of wives and a woman of innumerable virtues." He was appointed king's attorney of Mecklenburg, November 3, 1767; of Botetourt, May 4, 1770, and of Lunenburg, October 18, 1770; county lieutenant and presiding justice of Charlotte, April 11, 1772; and clerk of Halifax County, November 17, 1772. He was for many years a vestryman and churchwarden of Cornwall Parish. He was a member of the Mercantile Association of 1770; of the Convention of August, 1774; and chairman of the Charlotte County Committee, 1774-1776. This committee, at its meeting on January 13, 1775, endorsed the resolutions of the late Continental Congress, and at its meeting of February 6, passed strong resolutions respecting persons suspected of disloyalty to the American cause. He was a member of the Convention of March 20-27, 1775, and that of July 17 to August 26, 1775. He was a member of the first state Committee of Safety, August to December, 1775; of the CONvention of December 1, 1775 to January 20, 1776; of the second state COmmittee of Safety, January to July, 1776; and of Convention of May 6 to July 5, 1776. He is frequently mentioned in the papers of Col. William Cabell, the elder, of "Union Hill." He was a member of the House of Delegates from 1776 to 1778. He was elected a judge of the first General Court of the new republican form of government on January 23, 1778, under the act of October session, 1777, and commissioned on February 28, 1778, and so continuing, became one of the judges of the court of appeals, as organized by the act of May sesion, 1779, which exalted position he continued to fill until the constitution of the court of appeals was changed by the act passed by the General Assembly on December 22, 1788. He was again chosen under the new constitution a member of the same court, and continued to discharge the duties thereof until 1807, when he resigned. He was a member of the celebrated Convention of June 2-27, 1778, and voted for the Constitution.

He married (2nd) March 6, 1792, Miss Priscilla Sims, aged 16; she died in September, 1803, and he records that her loss was irreparable to him and to her family.

His letter of resignation, dated January 1, 1807, addressed to Gov. William H. Cabell, begins thus: "Having served my

country for forty-two years, without intermission, - twenty-nine of those years devoted to the judiciary Department, - and being now in the seventy-fifth year of my age, I think it time for me to retire from public business to the exalted station of a private citizen." On August 1, 1807, he wrote to his son-in-law, Col. William Cabell: "I had served the public a great many years, and I know with faithful integrity, I had arrived to a time of life that every man ought, in my opinion, to retire, and not remain and die at his post as some of my brethren did." He died on Tuesday, January 23, 1818, at his seat in Charlotte. A notice of him in "The Richmond Enquirer," July 7, 1818, begins: - "This venerable and highly respected gentleman was perhaps the oldest of the few surviving patriots who took an active part in the Councils of his Country, in her first struggle for Liberty."

In 1791, Col. Clement Carrington, 29, a resident of Charlotte County, wrote to his sister and brother-in-law, Anne and William Cabell Jr., of Union Hill, Nelson County, regarding a visit by George Washington:

"The beloved President passed lately through the county. He rested a day with Mr. Coles. He is in perfect health. We did not address him, as is the custom, but the laborer forsook his work and the lame forgot his crutch to gaze on him as he passed, and we looked at him without mercy."

Richard Venable, the young Peytonsburg lawyer, followed Washington to Charlotte Court House. On Monday the 6th, in anticipation of his arrival there the next day, he wrote in his diary: Great anxiety in the people to see Gen. Washington. Strange is the impulse which is felt by almost every breast to see the face of a great man - sensations better felt than expressed. "

Many years after the President's visit, one of the Coles ladies was asked what he had said while at her dinner table. She replied that the only thing she could recall was that he had praised her pudding!

Will of Clement CARRINGTON

In the name of God amen. I Clement CARRINGTON of the County of Charlotte and State of Virginia do make and appoint this to be my last will and testament by which I do hereby revoke all other wills and testaments by me heretofore made. First - I give my beloved daughter Nancy and to her heirs forever my estate on Dan River, which is now in her possession, in addition to the slaves already given to her by deed, I give to her Susanna. Second, I give to my daughter Nancy and her heirs forever my estate on Stanton river, purchased by me from Robert CARRINGTON, with all the slaves on said estate, also the crops growing on said estate and the horses and all the other stock and appurtenances to said estate belonging. - Third, I do give to my daughter Jane and her heirs forever my estate on Hyes(?) which I purchased from Doct JONES and which is now in her possession and all the slaves now on said estate. Fourth, I do give to my daughter Jane and her heirs forever, my estate on Hyes, which I purchased from Doct ATKINSON with all the additions since made to it by purchases also all the slaves, stock, crops, now growing and other appurtenances to said estate belonging which two estates hereby given to my daughter Jane and the estate called Templeton formerly given by deed to husband Doct W. W. CARRINGTON cost me the sum of fifty seven thousand dollars. Fifthly, I also give to my daughter Jane ten slaves, viz, Abram and others now in possession of William W. CARRINGTON at his estate Templeton. Sixthly, I give to my daughter Mary for the term of her natural live the plantation in the county of Charlotte on which I reside and known by the name of Edgehill with all the slaves on said estate and all the houses and other stock appurtenances to said estate belonging, also I give my daughter Mary my carriage and all my household furniture excepting my mahogany book case and my books which I give to my son in law John B. MC PHAIL. Should my daughter Mary die leaving issue of her body, I give at her death the plantation and negroes aforesaid and the increase of said negroes to said issue, but should she die without leaving issue of her body, I then give said estate and said slaves and their increase to my daughters Nancy and Jane and their heirs forever to be equally divided between them and also the aforesaid household, furniture and appurtenances to be in like manner divided. Seventhly - I give to my sons-in-law John B. MC PHAIL and William W. CARRINGTON and their heirs forever all my lands in Kentucky lying on the Cumberland River to be held by them as tenants in common. Everything I give to my sons-in-law John B. MC PHAIL

and William W. CARRINGTON all my endits, bonds, money in bank and bank stock and ____stock to be equally divided between them. I give to my sons-in-law John B. MC PHAIL and William W. CARRINGTON all my unbroken colts and all my different plantations to be equally divided between them. Tenthly, I give to my son-in-law John B. MC PHAIL my gold watch that I received from Abram VENABLE, and now in my possession. Lastly I apoint my son-in-law John B. MC PHAIL to be sole executor of this my last will and testament and I desire and request that no security be required of him and that no inventory of my estate be ordered or taken. = In testimony where I have hereunto set my hand and affixed my seal this second day of September in the year of our Lord 1847. /s/ Clement CARRINGTON (seal)
