1. **Sally WATKINS** was born about 1748. She died 1786 in Charlotte County, VA.

"VII. SALLY WATKINS was another daughter of Thomas Watkins of Chickahomony. She married Capt. John SPENCER of Charlotte. She too was eminent for her devoted piety and sound sense. She led a very retired and noiseless life, contented at home, and devoting her time and attention to the training of her children. How successful she was in accomplishing this good work as happily illustrated in the lives of her children,, two of whom it has been my good fortune to know, viz: Capt. Thomas Cole SPENCER, who died some few years since, leaving to his amiable family a name synonymous with all that is virtuous and good. I have seldom known more really kind-hearted Christian gentlemen than these two respected brothers. Their sisters emigrated to the South, carrying in good and honest hearts the seeds of holy wisdom sown by a mother's hand bringing forth in their lives the matured fruits of righteousness."

Sally married **John SPENCER of Charlotte Co., VA.** John was born 16 Dec 1745. He died 26 May 1826 in Charlotte County, VA.

Note:

John served as deputy sheriff of Charlotte County VA 1771-1773.

John Spencer was a Lieutenant of a Virginia State Regiment in the Revolution from 1778-1781. He served in Edmonds Command, Artillery. He was ordered to Richmond for instruction Feb. 12, 1781 and was on a supernumerary list 1782. He was awarded 2,666 acres of land.

The 1782 Tax List for Charlotte County showed a John Spencer with 6 white titheables and 10 negros. This was probably John, although the number of white titheables is puzzling. John's first wife died in 1786. In that year John sold the property he had inherited from his father to his brother, Thomas Spencer for 300 pounds.

In 1788 John married Drucilla Bedford, widow of Col. Thomas Bedford. She was a Methodist and John may have been, or become one, too. In Dec 1788 John & Drusilla became the guardians of Drusilla's children by her first husband Thomas Bedford, namely Jinsey, Peggy, and Charles Wesley Bedford. In 1792 the guardianship for Peggy and Jinsey was transferred to Hillery Moseley. Also it appears in 1792 that there was another child of Thomas & Drusilla Bedford that John had assumed the guardianship for, namely Joseph. In 1789 John and Drucilla Spencer were visited by Methodist Bishop Asbury, who commented in his diaries on his hospitable reception, a continuation of hospitality he had received from Col. Thomas Bedford some twenty years before.

Drucilla died in 1807, and we hear nothing more of John Spencer for some 20 years. It appears that at some point he had given all his property to his children, and perhaps he was living with one or another of them. In any event, on April 18, 1827 he made his will, proved in Charlotte County on March 3, 1828. It bequeathed "all my Estate both real and personal given and divided in my lifetime among my children Thomas C. Spencer, Henry Spencer, Frances A. Allen, Jinny Yarbrough and Elizabeth Julia Todd" to "remain as heretofore". It also bequeathed to his son, Thomas C. Spencer, a negro man, "now in his possession, providing he raise as soon as may be convenient after my decease one hundred and fifty dollars to be secured by him and my son Henry to their sister Jane Yarbrough and her children, by her marriage with Tho. Yarbrough." As executor he appointed son Thos. C. Spencer. The witnesses were John James R. Spencer and

Matthew L. Spencer, his grandsons. There are some tantalizing mysteries about John's life. There were some slightly unusual gaps between the birthdates of his known children. We are not sure what happened to his Revolutionary War Land Grant, although there is a record of a John Spencer who made several assignments of parts of a large grant. We don't know why he sold all his property to his brother in 1786, nor why he found it necessary to make a contract with Drucilla whereby he would end up owing her 280 pounds. Nor do we know what he was doing from 1807 to 1827, nor why he saw fit to give all his property to his children (perhaps he stayed with some of them who were in Georgia).

John Spencer enlisted, 1778, serving until 1780 as a bombardier in the Virginia state regiment of artillery and subsequently was appointed lieutenant in same regiment. He was born in Charlotte County, Va.

Thomas Bouldin (1706-83), a patriot, rendered material aid to the colonies during the Revolution. He was born in Pennsylvania; died in Charlotte County, Va.

Thomas Spencer was a member of the Committee of Safety from Virginia, where, in 1793, he died. He was born in Virginia.

BOOK EIGHT 1789 - 1792

1789 August 31 Pg 33 Court held for the examination of William McElhany and

Frederick Briggs, who stands committed to the common jail on the suspicion of feloniously, stealing, taking and leading away on the 2nd day of this instant, two horses, towit, a bay and a sorrel, of the value of ?20, each belonging to John Spencer. The prisoner was led to the bar in the custody of the Sheriff, and being charged with the fact, saith he is in no wise guilty thereof. Whereupon, sundry witnesses were produced, sworn and examined, as well on behalf of the Commonwealth as the sd Briggs/McElhany, and he was fully heard in his own defense. On consideration thereof it is the opinion of the Court, that the prisoner, the said Briggs/McElhany is guilty of stealing the horses in conjunction with the said McElhany/Briggs, and that he ought to be tried at the next district court to be held in the Court House, in the county of Prince Edward in September.

John Spencer, on oath saith that on the 2nd day of August, instant, he was possessed of two horses, one a bay, and the other a sorrel. Which two horses were missing out of his pasture the next morning, and examining his pasture fences, could make no discovery where they got out. On the 5th day of the month, in the evening, came to his house, Mr Walton, with a letter directed to Capt Bedford, that the two prisoners, McElhany and Briggs, were apprehended in the county of Nottaway and committed to the jail of that county, on suspicion of stealing two horses, a bay and a sorrel. Receiving this information, the deponent attended the examining court of Nottaway, and there he saw his two horses in the care of Col Freeman Epps, said to be taken from the prisoners. Which horses, the deponent saith, were his property, and that he never disposed of them to any person whomsoever. Further, deponent saith not. Col Freeman Epps, before the Court, on oath saith that on the morning of the 3rd day of August, about noon, he received information that there were two men in camp, in a neck of woods, near the plantation of Mr Thomas Epps. On this information, he, the deponent, collected together several men to go in search of, and endeavor to apprehend them. Being conducted, with his company, to the camp, he proceeded to apprehend the prisoners. On approaching, the said McElahany and Briggs ran off. Being pursued by the deponent and his company, the prisoners were taken near their encampment. The deponent directed the company to keep the prisoners apart, in order that they might be examined more particularly. On examination, the prisoner McElhany told this deponent, that they, the prisoners, had two horses at the camp, but that the horses had run off. They had taken the horses the evening before at a plantation about two miles below Little Roanoake Bridge. He believed a widow women lived there. One of the company, recollecting the plantation from the description given by the prisoner, asked him if it were not the plantation whereof Mr Bedford formerly lived. He, McElhany, replied, "Yes, that was the name of the person who lived there." The prisoner, McElhany, informed this deponent that one of the horses was a large bay, the other a sorrel. The horses, when found, answered the description given by the prisoners. The deponent saith, the horses were found about 300 or 400 yards distant from the camp, making towards the road. They were pursued and caught about a mile distant from where to prisoners were encamped. The horses were then carried to a house of a Mr Epps, where the prisoners had been sent on before. This deponent then took the prisoners apart, and took McElhany to the horses, and asked if they were the horses he, McElhany had stolen. His answer was, "Yes, the bay horse I had road down, and Briggs, the sorrel." This deponent then returned McElhany to the house and took Briggs to the same horses and asked him if he knew them. He also answered, "Yes, I road the sorrel and McElhany the bay." McElahany, when he was carried to the horses, inquired of this deponent, whether the bridles and saddles were safe. The deponent answered, the saddles were, and the bridle on the bay horse, but the sorrel horse had lost his. McElhany then said he had well secured the bridle on the bay horse, by putting the stirrup through the bridle reins, but that Briggs had carelessly put his bridle over the sorrel horses' neck, which he supposed would be lost. Further this deponent saith not Francis Fitzgerald, of Nottaway County, before the court on oath saith, that on Monday, the 3rd day of August, instant, he was informed by Mr Epps that one of his negroes had discovered some white men in camp, in the woods near his plantation. He, Epps, requested assistance of this deponent, to apprehend them. He, the deponent, went to the plantation of Mr Thomas Epps, and with others, were conducted near the camp, from whence the deponent saith he discovered a man and horse. The horse was either a bay or a sorrel. The deponent then showed himself to the prisoners, he being in front of the company, and ordered the prisoners to surrender. Upon which they, the prisoners, immediately ran off. The company and the deponent pursued them. The prisoners separated, and the deponent went after the prisoner Briggs, and took him, and inquired his name. He answered, "Briggs". After some little pause, the prisoner inquired who

had discovered them. The deponent made no answer to the question. The prisoner then said that he supposed the deponent and his party, had pursued them from the place where they had taken the horses. The deponent requested the prisoner to inform him the whole truth of the matter. The prisoner answered he and McElahany had taken two horses a small distance below Little Roanaoke Bridge, from a plantation where there was a large red house. The deponent and the company went with the prisoner, to the house of Mr Epps. After being there some time, Briggs desired to speak to this deponent in private. While together the sorrel horse was produced and the deponent asked Briggs if he knew that horse. Briggs answered that was the horse he road down, and said he was apprehensive that McElhany would swear his life away, as he, McElhany had taken both horses. The deponent then asked McElhany, if he did take both horses. McElhany answered they were both taken together, and that he might have taken hold of both of the horses, but that Briggs had bridled the sorrel. Further, deponent saith not Sterling Rack Thornton, being first sworn saith that on the 3rd day of this instant, having business with Col Epps, and on his way there he met with Thomas Epps, who informed him, that he understood by his boy that there were two men just by his plantation in the woods. He requested this deponent to accompany him, and see who they were. On which the deponent went to Col Epps' and joined the company collected there, to take the men said to be encamped in the woods. After the prisoners, McElhany and Briggs were committed, the deponent was summonsed as a guard. When going to the jail, the deponent asked Briggs what kind of saddle he had. He answered a very indifferent one, but that McElhany's was a very good one, about half worn and that he expected McElhany, would sell it. Two days afterwards the deponent went up to the jail and spoke to Briggs about the saddle. McElhany said he would sell his, and that the deponent might go and see it. If he liked it, then he might give him what he thought it was worth. The deponent inquired where it was, and McElhany answered he supposed at Col Epps'. The deponent later spoke to Col Epps about the saddle and told him McElhany had sold him the saddle if he liked it. Col Epps told the deponent the saddle was at his, (Epps) house. When the deponent went, Col Epps was from home, but from the description of the saddle, the deponent found it, took it away, and offered to pay the said McElhany for it. But he refused to receive pay and desired the matter might be deferred until the evening. Further, deponent saith not.

Whereas, a treaty of marriage hath been "agitated?" and concluded between said Allen and Mrs. Winfrey, it is understood that after they are married, she shall be at full liberty, without let nor hindrance from said Allen, to hold, use, and enjoy any of said property she now possesses, as if she were unmarried, any law, usage or custom to the contrary, notwithstanding. If said Frances shall outlive John Allen, he shall leave her in as comfortable, eligible, advantageous, and ample a situation as regarding a mansion or residence as she now enjoys, on the property of Jesse Winfrey, which upon the solemnization she will relinquish. Any property which shall be legally hers is to be under her own separate control.

Georgia did not have enough men to fill their quota so they went up to Virginia and Maryland and got men by promising them big parcels of land if they would fight for GA. Most of GA at that time was Indian land and you had to have a passport to cross it.

The profit over the support of the family to be put on interest. If my executors think best, they may rent or sell part of the estate for the support of the family. Mrs. Winfrey to have Negro Lucy & her child.

I desire my executors sell 400 acres of land in Warren County, also my Negro man Hannibal a blacksmith, to be hired out and money put on interest

I desire my daughters Martha & Nancy to be after my death put in boarding female school for two years.

I give unto my daughter Frances, 335 acres of land in Columbia County, the land I bought of the estate of N. H. Collins, my sorrel horse & saddle, one feather bed & furniture, four Negroes, Betty & her two children & Jim.

I give unto my son Benjamin 600 acres whereon I now live after the death or marriage of his mother, also Negro man named Daniel & after my death the Negro named Phil.

I give unto my daughter Martha 200 acres of land on Town Creek in Hancock County & 550 acres lying in Edgefield District South Carolina, two Negroes Mary & her child, one feather bed & furniture, one horse & saddle.

I give unto my daughter Nancy 900 Acres in Effingham County, granted to William Gardner, three Negroes Jimmy & her two children, one feather bed & furniture, one horse & saddle.

I give unto my Grandson Jonathan Winfrey Wood two small Negroes named Susan & Elvy.

Having gone through the legatees, except my Grandson Robert W. Walker whose mother was my daughter Julia now deceased was the wife of Adam Walker, now deceased received three Negroes, named Nancy, Sam and Harry, now there are six in number, Negroes having been lent to my deceased daughter. I wish they to be delivered to my grandson when he comes of age.

The residue of my estate to be divided equally among my children, Sarah, Benjamin, Francis, Nancy & Martha.

I appoint my wife Francis A. Winfrey my executrix & my son Benjamin Winfrey, Jonathan Wood & James Walker and my friend Peter Crawford, Esq.

Witness: A. Crawford, Isaac Vaughn James Yarbrough.

Signed: Jesse Winfrey.

There is a question about the birth year of Jesse Winfrey. Many sources give it as 1764. However, Mary Hughes Walton Winfrey died before November, 1760, and unless Jesse was the child of Judith Haskins, he could not have been born in 1764. Since he named a daughter, Martha Hughes Winfrey (after Mary's mother), and since he was given a farm in Columbia Co., GA, by a George Walton, the preponderance of evidence indicate he was the son of Mary Hughes Walton. In addition to this evidence, Jesse's name is found on a list of Powhatan Co., VA Oaths of Allegiance, 27 Sept. 1777. If Jesse was born in 1764, he would have been thirteen years old when he signed that document. This is possible, but unlikely. Have alot of proofs for some of the Winfrey's that end up in Olgethorpe Co., GA. Also have copy of John Sr. Winfrey's will, and more on Jesse for one of his line.
