

# Family of Sherwood WALTON

## First Generation

1. **Sherwood WALTON** was born 10 Jul 1728 in New Kent Co, VA and was christened<sup>1</sup> 11 Aug 1728. He died<sup>2</sup> about 1811 in Amelia County, VA.

Sherwood Walton son of Robert and Frances born June 10, 1728 married Ann (Susanna), died in 1811 in Amelia Co., VA, will probated in that year.

They met at a Court held for Halifax County at Hampton Wade's house, on Tuesday the 19th day of May, 1752. Nathaniel Terry, Gent. was appointed Sheriff.

"A Commission of the Peace from the Honorable Robert Dinwiddie, Esq., His Majesty's Lieutenant Governor and Commander in Chief of His Colony and Dominion of Virginia, bearing date at Williamsburg the 28th. day of April in the year of our Lord 1752, directed to William Byrd, William Wynne, Peter Fontaine, Junr., James Terry, William Irby, Nathaniel Terry, Robert Wade, Hampton Wade, Andrew Wade, Hugh Moore, and SHERWOOD WALTON, Gentlemen," was read. Oaths were administered to the various county officers, but since it was mostly a ceremonial occasion, no real business to speak of was taken care of.

"The interest that was always attached to court at once began to draw new settlers to Punch Spring. The territory was becoming more thickly settled, but the General Assembly for added safety wanted towns established in open areas. In 1759 it was ordered that 100 acres belonging to James Roberts, Jr., and adjoining the courthouse be laid off into a town to be called Peytonsburg. Pursuant to the Act of Assembly, Sherwood Walton laid off 104 acres into 210 lots, the plat of same being presented at court on July 16, 1761."

1752- Halifax County was created out of Lunenburg and included what is today Pittsylvania. The justices of the peace were William Byrd, William Wynne, Peter Fontaine, Jr., William Irby, James Terry, Nathaniel Terry, Robert Hampton, Andrew Wade and SHERWOOD WALTON. In the next year the following were added from the area that is today Pittsylvania-Thomas Dillard, Thomas Calloway, Samuel Harris, Benjamin Clement, Peter Wilson and Robert Pusey.

1767, June 1 - Pittsylvania County was cut off from Halifax County

In the "Johnson Report", compiled Harold Johnson ca. 1999, Harold listed Sarah Johnson as the daughter of Joseph Johnson. Her husband was PETER WOMACK. In Will Book 2, Page 28 of Lunenburg Co., VA, Joseph Johnson's will names his daughter Sarah Womack. Harold Johnson also cites in a Lunenburg Co. court case ca. Oct 1761, JACOB WOMACK and his wife, plaintiff, were awarded eighty six pounds ten shilling current money. Harold didn't specifically indicate this award was a part of the same suit Stephen Wood, husband of Ann Johnson, dau. of Joseph Johnson, had filed. Wood had previously filed a suit against SHERWOOD WALTON, executor of the estate of Joseph Johnson.

Joseph Witt appears only twice in the records of Halifax County (VA) before his father's death in 1781. He and

Elijah Witt witnessed a neighbor's deed on 21 December 1775.[2] On 6 October 1777 he witnessed a deed from Charles Henderson to SHERWOOD WALTON and another deed from SHERWOOD WALTON to William Mayes Jr.[3] Unlike his father, he signed his name in each case.

Josiah Ellington [EL.1.3] appeared as a tithable in Amelia County (VA) first in 1764. He bought 400 acres on Walnut Branch of Flat Creek from William Mullins 22 January 1774. Ellington married Elizabeth Bruce and together they sold 200 acres on the Little Nottoway River to Simeon Walton 23 April 1778. This was land Josiah bought from George Walton and Simeon Walton on 9 Dec 1772. He was living in Lunenburg County 9 Oct 1779, when he sold his Walnut Creek tract to SHERWOOD WALTON.

Signed by Benjamin Clements on March 23, 1771. Witnessed by SHERWOOD WALTON, Abraham Vaughn, and Thomas Chaffin.

Rett, I'm working on John Scurry, a Baptist minister. He was living in Chesterfield County in 1786 and moved to Amelia County in 1791. I think he was a preacher/minister from 1786-1818 and died in Amelia County in 1818. He married 22 May 1814 Susannah Walton. No issue. Needed: the date and place of his birth, the names of his parents, his residence from birth until 1786, the location of the cemetery in which he is buried.

2. **Gen. Matthew WALTON Congressman of KY** (Sherwood) was born about 1754 in VA. He died 18 Jan 1819 in Springfield, Washington Co., KY.

US Representative from Kentucky; received a limited schooling; member of the conventions held in Danville in 1785 and 1787; member of the first State constitutional convention in 1792; member of the State house of representatives in 1792, 1795, and 1808; elected as a Republican to the Eighth and Ninth Congresses (March 4, 1803-March 3, 1807); died in Springfield, Ky., January 18, 1819; interment in Springfield Cemetery.

Matthew Walton (1748-1819) was a son of Sherwood and Susannah Walton. George "the Signer" Walton was a son of Robert and Mary (Hughes) Walton II. Sherwood was a brother of Robert II, so their sons would have been 1st cousins. Matthew Walton was a wealthy landowner. I found 48 land grants to him in Kentucky, a total of 67,698 acres./vsm

"1789, October 23. Petition of Matthew Walton and other inhabitants of the County of Nelson that it would greatly increase the interest and promote the happiness of the petitioners by establishing a warehouse and inspection on the lands of Matthew Walton on the south side of Salt River at the first Yellow Bank below the mouth of Long Lick Creek, the situation being between the two principal salt works in the District of Kentucky about three miles from the long lick and about three miles from Bullitt's Lick. The river at all seasons of the year is navigable. It is contiguous to any public roads. They pray an Act establishing a warehouse and inspection."

Initially, it was the fact that Thomas named a son Musco (see Salvatore MUSCOE of Essex above), together with the numerous Essex to Amelia migrations, that led to speculation that this family was kin to the Essex Co, VA family, but the source is still not known for Thomas of Amelia having been the son of Thomas of Amwell and/or grandson of Timothy of New Castle, Salem, Essex and Somerset. Joshua ATKINSON, s/o Thomas, was born ca 1755 according to his 1833 Adair Co, KY pension application, which states that he enlisted in the Revolutionary War in Amelia County, Virginia.

THOMAS WALTON ATKINSON

Thomas Walton Atkinson was born ca. 1778 in Amelia Co., VA, son of Joshua Atkinson and his first wife, Frances Walton. Thomas is first found as an adult in Adair Co., KY where his father and the other members of the family are also living. In 1803 Thomas Atkinson made proof for 400 acres (Adair Co. Ct. OB, 1802-1808, p. 60). He was appointed Paymaster of the 52nd Regiment of Militia on Oct. 3, 1803 (OB, p. 84). In 1804, Thos. W. Atkinson "produced a legal license and took the necessary Oaths required by law he is permitted to practice as Such in this Court (Adair Co., KY Ct. OB, 1802-1808.) On May 5, 1806, Thomas W. Atkinson is appointed Attorney at law in behalf of the Commonwealth. He relocated to Montgomery Co., TN by 1819 where he appears to have been a merchant, possibly in the tobacco trade.

Thomas W. Atkinson served in the War of 1812 as Sgt. in Capt. Butler's Company, KY Militia from 18 Sept. 1812 to 12 Oct. 1812 and as Capt. in Ky. Vol. Mil, 24 Aug. 1813 for 3 months. He was at the Battle of Thames. (Source: Montgomery Co., TN Genealogical Journal - Soldiers of 1812 and Revolutionary War, from information provided by Anita W. Darnell.)

He was married twice - first to Elizabeth Hundley, and second, 6 Nov. 1810 to Elizabeth "Betsy" Carlile, b. ca. 1791, d. ca. 1881, daughter of John and Sarah (Cates) Carlile.

It is unclear at this point if the three children of Elizabeth (Hundley) Atkinson were children of Thomas W. or if she had a prior marriage which produced these children. We have thought in the past that Elizabeth Hundley was first married to a Fra. (Francis?) Atkinson before her marriage to Thomas W. Atkinson. In addition, it was believed that she was second wife of Thomas W. Atkinson. It appears we had the order of the marriages reversed. The indication that she had previously been married to Fra. (Francis) Atkinson comes from a power of attorney in Nottoway Co., VA, as follows:

(Nottoway Co., Va., DB 10:375) August 31, 1840. Quintus C. Atkinson of Montgomery County, Tennessee, Jno. E. Trabue and wife Elezabeth (formerly Atkinson) of Robertson County, Tennessee - power of attorney to David D. Mason of Logan County, Kentucky, to receive the distributive share OF OUR MOTHER ELIZABETH ATKINSON LATE WIFE OF FRA. ATKINSON, from the estate of our grandmother Elezabeth Overton and our grandfather Josiah Hundly.  
Att: Montgomery County, Tennessee, Robertson County, Tennessee, 31 Aug 1840. Recorded 30 Sep 1840.

We have thought this document an indication that Quintus C. Atkinson and Elizabeth (Atkinson) Trabue were children of the above mentioned "Fra. Atkinson." But the document does not so state. It merely says that their mother was the late wife of "Fra. Atkinson." Since this information is from a published abstract, we are now trying to obtain a copy of the handwritten document to compare with this abstract. If Elizabeth Hundley died ca. 1809 and her daughter, Elizabeth (Atkinson) Trabue was born ca. 1809/10, it seems she should be daughter of Thomas Walton Atkinson and yet the power of attorney mentions "Fra. Atkinson" as their "late" mother's husband. More research is in progress to try and solve this mystery.

The proof that Thomas Walton Atkinson was married to Elizabeth Hundley is found in the following power of attorney in Nottoway Co., VA. Notice that this document mentions that Elizabeth Hundley was the "late wife" of Thomas W. Atkinson.

Elizabeth (Hundley) Atkinson, was born 22 Oct. 1783 (Hundley Bible Records, Library of Va), d. ca. 1809, daughter of Josiah and Elizabeth (Motley) Hundley of Amelia Co., VA. Her father, Josiah Hundley, died when she was still a minor and soon thereafter her mother remarried to Benjamin Overton. (Note: Benjamin Overton had previously been married to Millie Atkinson who was sister of Joshua Atkinson, father of Thomas Walton Atkinson.).

Elizabeth (Hundley) Atkinson had the following children but as pointed out above, it is unclear at this time if they were by Thomas W. Atkinson or by a previous marriage.

1. Frances Atkinson, b. ca. 1803, d. after 1880. Married (1) \_\_\_\_\_ French, and (2) Robert Mason. Frances and Robert Mason are found in the 1850 and 1880 census records living in Oldham Co., KY.
2. Quintus C. Atkinson. It is difficult at this time to identify Quintus in the records. We do know from the power of attorney that he was living in Montgomery Co., TN in 1850. There was a Quintus C. Atkinson listed in 1850 in Memphis, TN, age 40, occupation, Merchant, with wife Mrs. E. Atkinson. This could possibly be Quintus, son of Elizabeth (Hundley) Atkinson, and the age off a couple of years which seems to have happened a lot in these old census records.
3. Elizabeth Atkinson, b. ca. 1809/10, KY, married Dr. John E. Trabue.

Children of Thomas W. Atkinson & Elizabeth "Betsy" Carlile:

1. Sarah Cates Atkinson, b. 1816, d. 1908 (Tombstone Inscription, Trice-Leigh Cemetery, Montgomery Co., TN). Married (1) \_\_\_\_\_ Harris, and (2) John W. Lackey. In the 1880 census, Elizabeth (Carlile) Atkinson, age 89, is listed in the household of John W. Lackey and his wife Sarah.
2. T.W. Atkinson, Jr., b. ca. 1825, d. before 1860. There is some confusion regarding his marriage. In the 1850 census for Montgomery Co., T.W. Atkinson, Jr. is listed as age 25 with a wife Henrietta, age 24. One source shows he married Henrietta E. Trice, Jan. 25, 1847 and another source shows he married Henrietta Tanner on the same date. This may be confusion caused by the presence of another Thomas Atkinson in Montgomery Co., TN who is also listed in the 1850 census for Montgomery Co., age 30, b. TN, with a wife Henrietta, age 25.
3. Quintilla Atkinson, b. ca. 1828, TN, married 29 Aug. 1846, Montgomery Co., TN. to Matthew Beverly Clark. They are found in census records living in Muhlenberg Co., KY. In the 1880 and 1900 census records, Quintilla's parents are listed as both born in KY. However, from a very brief abstract found of Thomas Walton Atkinson's will, she is mentioned therein as his daughter so her father should be listed as born VA.
4. Joshua Atkinson, b. ?, d. before 1850. Married Elizabeth A. Watkins, ca. 1838, Todd Co., KY.
5. ??Sherwood Atkinson.

Thomas Walton Atkinson died in 1862, Montgomery Co., TN and left a will dated 24 April 1858. A copy of his will has been sent for and hopefully will answer some of the questions still remaining.

Web posting by Rhoda Taylor Fone: Does anyone know the identity of Sherwood Atkinson who received a land grant in VA March 26, 1765 described in record book 1737-1770 - counties of Halifax, Pittsylvania, Henry, Franklin and Patrick - as "400 acres beginning at white oak in first bent of Pig River above mouth of Doe Creek"? Any clues will be greatly appreciated.

Trigg County, KY 1820: The first suit filed was a case of debt of Jeremiah and Moses Brown, assignees of Sherwood Atkinson plaintiffs, against John G. Reynolds defendants. A demurrer was filed by defendant's attorney and the case thrown out of court.

6. **Charlotte WALTON** (Sherwood) was born about 1764 in Amelia County, VA. She died in Kentucky.

Web posted by Gary Young: There is considerable confusion about the men named Anthony Hundley, but I feel certain the Anthony who married Charlotte Walton was the son of Anthony Hundley who died in 1784 in Amelia Co., Va. In some old sources the Anthony Hundley who died in 1811 in Washington Co., Ky. was believed to be son of Anthony (d 1784), but Anthony (d 1811) was the son of Charles Hundley of Amelia Co. Two Anthony Hundleys settling in Washington Co., Ky. caused the confusion. The two men were probably cousins, but they were not much associated in Washington Co and lived in different neighborhoods. Your Anthony Hundley was quite rich due to his connection to his wife's brother, Gen. Matthew Walton.

Web posted by Mary Lou Franklin: There is some evidence in court records that Anthony Hundley and Charlotte (Walton) Hundley may have had 6 children. Do you know anything more about their children? I believe 3 of the children's names were Frances F. (my ancestor), Susan M. and Sherwood W. I have also seen the name John Boswell Hundley mentioned as a son in RootsWeb.

Web posted by Kent McMahan: I have compiled data only for the children of Anthony's son William Hunley, Sr., and wife Lucretia Wynne, because my wife descends from them. I have nothing substantial in my database on the children of Anthony's son Anthony Hundley, Jr., and wife Charlotte Walton. However, I just received yesterday notes from a descendant of that couple who said their children included John Boswell Hundley (her ancestor) b. 14 Aug 1795 in KY, who on 16 Jul 1822 in Louisville, KY, m. Urath Owings Dorsey (b. 5 Oct 1794). The other children of Anthony & Charlotte were given as: Nancy Hundley, Susan M. Hundley (m. Stephen Ray), Sherwood Walton Hundley, Frances Hundley, Charlotte Hundley, and William Hundley.

Charlotte married **Anthony, Jr. HUNDLEY**. Anthony, was born in Amelia County, VA. He died By 1819.

Web posted by Mike Martin: According to my info, the Anthony who died 1811 in Washington Co. KY was the son of Anthony Hundley and Ann Dupuy. He had a brother named Charles whom I have no data on, at all. Anthony was born c. 1742, probably in Amelia Co. VA, so the age could be right for the children to be from a second wife, and his will lists sons, Elisha and John. I have the first marriage to Charlotte Walton in Amelia Co. VA 28 Sept 1785.

Web posted by Ann Snipes:

A little something to add to the mix. My interest in the Anthony Waltons of Washington County, KY is through the marriage of Stephen Ray to Susan M. Hundley, Washington County on 30 Nov 1809. In studying the Court Order Books in Springfield, Washington Co., KY this past October. I found the following. It doesn't answer any questions, but possibly raises some as to the death date of Anthony Hundley who died intestate. I have a transcription of the other Anthony Walton's will and will send that if you'd like. In Washington County, KY Court Order Book C, p. 119 June 14, 1819-It was ordered that John Calhoun, Raphael Lancaster and Elias Davison or any two of them settle with Mrs. Francis Walton, the administratrix, will annexed of Matthew Walton, deceased who was administrator of Anthony Hundley deceased, the account of Hundley to be studied and a report to be made.

Court Order Book C, p. 133, July 12, 1819, Frances Hundley, an infant orphan of Anthony Hundley, decd. came and chose Edward B. Gaither as her guardian. Gaither came with P.I. Booker and Jno. Hughes as his securities to secure orphan's estate.

Court Order Book C., p. 134, July 12, 1819. A settlement of acct. of the former administrator of Anthony Hundley deceased was returned and ordered to be recorded. and on p. 135, Sept. 13, 1819. Ordered to be certified to auditor of public acct. John Calhoun, Raphael Lancaster and Henry H. Payne settled accts. of estate of Anthony Hundley decd. This is mentioned in Will Book C, p. 208, Francis Walton, adm. with the will annexed of Matthew Walton deceased who was the administrator of Anthony Hundley deceased said the sale of personal estate amounted to \$557.95. In Will Book C, p. 547, Stephen Ray appears as administrator "debonis" now of the estate of Anthony Hundley decd. Mentions balance due to the estate by adm. of estate of Matthew Walton decd who was adm. of A.Hundley, due \$943.42. There were others mentioned as renting A.Hundley's land, George Hall, Robert Wells, A. Bayne, and the rent of Jerry. This was dated 15 April 1823. A view of the original estate records may shed more

light.

The only other evidence I can find to estimate this Anthony Walton's death date is that Anthony Hundley sold to Stephen Ray land on 3 July 1813, part of survey in name of Walton and Hundley-Deed Book D, p. 273. Anthony had earlier sold another piece of land to Stephen on 17 August 1810, Deed Book C, p. 466, "on the north side of Beech Fork, part of survey in name of Walton and Hundley. No wife was mentioned in either of these deeds, so I assumed that Anthony's wife was dead at this time. She figures in several earlier deeds in Washington County. In the first Washington County, KY Deed Book A, p. 117, November 1, 1787, Anthony Hundley of Nelson County to James Dupey of Amelia County, Virginia a piece of land on south side of Chaplains fork and E. Side of \_\_\_Creek, 1435 acres part of a 16,676 acre survey to Hundley for 140 pounds of Virginis money paid by Dupey. Cahrolotte not mentioned in this deed, but in later ones dated 1794, 1796. I believe I saw reference in one of the previous letters of "before 1816" for his death. Yet it is 1819 before mention of his death is given in the court records. Matthew Waltons' will was written in 1804, but not proved until 7 Feb 1819. and is recorded in Will book C., p. 172. He mentions his sister, Charlotte Hundley and leaves her land, so we know she was alive in 1804. At least we know that Anthony Hundley was dead before Feb of 1819. I wonder where these folks are buried.
